I don't do them now but I have done private homes as well as historical places. I've gone alone, or asked someone along, or been asked along...we've had anywhere from a carload to just two of us. we never had leader/follower scenario. We would talk about whatever may be known about a place what has been reported, by whom if possible... decide what we thought (notice 'we') was the best game plan and then proceed. Sometimes we got stuff..lots of times nothing of note. We did though always manage to do good work and have a good time. For the most part none of us really came from a point of view of needing proof..we were more of a mindset to see what, if anything was going on and what was the most likely cause of it.
